

ENTRY PROCEDURE FOR TEAM SPORT TOURNAMENTS

Only countries which have properly entered their teams on time by returning the "Final Engagement Form for Team Sports" and by paying FISU a deposit of EUR 5,000 per registered team (Beach Volleyball: EUR 2,500), are entitled to enter the selection process.

1) NUMBER OF TEAMS PER SPORT

A maximum of one (1) men's and /or one (1) women's team per sport and country:

- The final engagement deadline for all team sports is **1 February 2013**
- Except for Beach Volleyball (which will have its team draw along with the 1st General Technical Meeting), the selection of teams and the pool draw will be held in Kazan, in conjunction with the Head of Delegations' Meeting from **3 to 7 April 2013**.
- One Final Engagement form per sport (tournament) must be sent to FISU.
- All of the other entry forms will be provided by the OC to the invited countries.
- All forms are available on the OC website **www.kazan2013.com** in "Acrobat reader" format (free download) and on the **FISU extranet**.

3) TEAM SELECTION CRITERIA

For the selection of team sports, where the number of entries is larger than the authorised participation level, the following criteria will be applied:

- a) The entry/ nomination and the payment of guarantee
- b) Those teams who finished in the top half of the previous Universiade competition will be automatically qualified to participate

The remaining participating teams will be selected by a wild-card system according to criteria defined by the FISU - CTI (geography and continental representation, FISU ranking, ISF ranking).

4) ITO REQUIREMENTS (REFEREES AND JUDGES)

- Each team must bring international referees as specified in the "Regulations for the Summer Universiade 2013 Kazan – Russia". These regulations are available on the OC website www.kazan2013.com in "Acrobat reader" format (free download) and on the **FISU extranet**.
- Countries not providing the required referees or judges must
 - cover the expenses of an international referee or judge from another country approved by FISU. In this case, further information concerning the above expenses and the related nomination procedures will be sent to the delegations in due time.
 - or
 - pay the Organising Committee a penalty fee of two thousand five hundred Euros (EUR 2500) per missing referee or judge at the moment of accreditation.

The Organising Committee will deduct such cost from the delegation deposit.

- The countries must inform FISU and the Organising Committee no later than **6 April 2013**, about the name and category of their referees and judges (1 effective + 1 non-travelling substitute per nominated referee or judge).

5) DEPOSIT PAYMENT MODALITIES (Art. 5.4.4)

- The deposit of EUR 5,000 / EUR 2,500 (net value - bank charges paid by your association) must be paid to the FISU bank account as stated underneath.
- As soon as your Final Engagement Form is received, you will be sent an invoice for the above-mentioned deposit, which will enable you to make the payment.
- Please refer to the instructions indicated on the invoice as regards the payment reference that should be indicated on the transfer order.

6) CREDIT NOTE FOR SELECTED TEAMS

- Should the team be selected and compete, FISU will credit your team sports deposit(s) to the Organising Committee, for the appropriate participation fees of your country.
- The Head of Delegation must present the "FISU receipt" to the Organising Committee, upon arrival at the Universiade Accreditation Centre.

6) CREDIT NOTE FOR NON SELECTED TEAMS

- FISU will credit your team sports deposit(s) to the Organising Committee, for the participation fees of other participants of your country in the Universiade 2013. The Head of Delegation must present the "FISU receipt" to the Organising Committee upon arrival at the Universiade Accreditation Centre or
- FISU will reimburse your payment upon request

7) WITHDRAWAL OF TEAMS

Should a team withdraw after having been selected, the payment will be kept as a penalty to cover the costs undertaken by the Organising Committee and FISU. (50% for the Organising Committee and the remaining 50% becomes property of FISU).
